The Future is Bright for Electric Vehicles

Over the past few months we have been discussing the value of beneficial electrification. This is an important accomplishment our industry provides for consumers. The electric industry has achieved this strategic vision by working in a responsible manner to provide you with an affordable and clean energy resource now and in the future.

In November we reviewed REA's power suppliers, Great River Energy and Western Area Power

Administration. Both providers work with REA to meet our energy needs in a cost-effective and environmentally responsible manner. In December and January we discussed investing in efficiency, specifically with air source heat pumps that provide significant savings and reduced energy consumption. Storage water heaters that heat at night when wholesale power produced by wind and hydropower is cheaper, was featured in the February article. Finally, in March I talked about efficiency – maximizing greenhouse gas reductions through the electrification of the economy, namely electrification through space heating, water heating and transportation to further reduce greenhouse gas emissions.

This month we will take a look at the future, specifically electric vehicles. While I describe this as the future, electric vehicles are a reality today. It is the adoption rate of electric vehicles that becomes the future, and thereby further contributing toward the exciting time of our industry.

Electrifying transportation is not a new concept

The first known electric car was developed in 1837, and over time interest in electric cars blossomed in the late 1890s. As roads improved and became more extensive, demand for greater range emerged.

But the rapid expansion of the country and the limitation of electricity to major cities and towns spelled the end of the electric car. The world wanted to be mobile and electric cars simply did not have the range required.



Fast forward to modern times and electric vehicles are dominating the automotive news. Thanks to the electric cooperative movement eighty plus years ago, electricity is available everywhere in the U.S., and environmental concerns are increasing awareness of the benefits of electric vehicles.

Over the next few months, my goal is to share more information about electric vehicles or EVs as they are called. Although the concept of electrically-powered vehicles was pioneered over a century ago, the appeal of EVs is clearly gaining momentum.

The best way for you to learn more about EVs is to actually climb inside one and look under the hood. We are excited to bring you the Electric Vehicle Learn & Drive Event set for Saturday, May 5 from 10:00 a.m. – 1:00 p.m. at the ATCC (see details below). Like most that have driven an EV, I'm sure you'll be impressed and surprised by the performance. Add to that the reduction in greenhouse gas emissions, and the future of electric vehicles looks very bright!

- Mrs. Nelson reviewed the Financial Report for January 2018. Mrs. Nelson noted electric sales were above budget and above last year January. Cold weather played a role in that, as well as a change to the timing of recording meter readings for billing.
- Mrs. Lundein informed the board that 94 students applied for the new REA

Scholarship Program. The directors randomly drew 18 names for the \$1000 scholarships. Scholarship recipients and their parents/guardians will be recognized at the 2018 REA Annual Meeting.

In compliance with Runestone Electric Association adopted rules relating to cogeneration and small power production, Runestone Electric Association is obligated to interconnect with and purchase electricity from cogenerators and small power producers whom satisfy the conditions as a qualifying facility. Runestone Electric Association is obligated to provide information free of charge to all interested members upon request regarding rates and interconnection requirements.

All interconnections require an application and approval to become a qualifying facility.

In case of a power outage

- Make sure the problem is not on your side (Members may be billed for service calls if the problem is caused by their own equipment).
- Check your own fuses and circuit breakers in your home and by the meter pole (Call us for help if you are unsure of the location of your breakers).
- Check with your neighbors to see if their power is off and if they have reported the outage.
- If the trouble is not on your wiring, please call (800) 473-1722 for 24-hour service. Please report any tree branches in lines, twisted wires, broken poles and if your neighbors are also out of power.
- Be sure to have one corded phone in the house, because cordless phones won't work when the power is out.
- Program the number above into your cell phone for easy access.
- Never assume we know you are without power. Always call to report an outage.
