Keeping everyone safe is REA's mission

As I write this article, it currently is 29 degrees below zero early Thursday morning on January 31, 2019. I am writing with a feeling of relief, as it will warm up by mid-afternoon to 4 degrees below zero — a much welcome reprieve for all of us hearty Minnesotan's from the last 48 hours. We at REA are so very grateful that our distribution system operated well in the extreme temperature and wind conditions.

On Wednesday, January 30, the wholesale market issued a maximum

generation event, calling for all generation to run. Minnesota and the upper Midwest was experiencing a high demand environment as you can imagine in these extreme and sustained temperatures. Wind generation was performing well below forecasts, also adding to the constraint. We are thankful for the baseload and peaking plant generation resources in place to meet the demand of electricity needed.

Our number one concern is people throughout events like this. We have proactive contingency plans in place to keep our employees safe when working outside. It is still very tough conditions in which our lineworkers and our energy management technicians have to experience. It is amazing to see their dedication to get your power back on and your heat restored. A huge thank you to our Energy Management Department for working around the clock the last 48 hours to ensure electric heating systems were functioning for our members. Also a huge thank you to our linemen who responded as outages occurred.

Our number one concern is your safety. We have dedicated employees who are focused on keeping your power and heat on. We accomplish this through proactive planning and by working together with you. Thank you to our members who called and worked with us as we talked you through the steps to restore your heat. A small number of members were unfortunately affected by equippment that at times was unable to withstand the extreme air and wind temperatures that we saw this week. Thankfully there are quick, easy fixes to reset the equipment. Our team worked around the clock to assist our members, talking them through the equipment reset or making a site visit to replace the equipment if needed.

I mentioned at the beginning that our distribution system operated well. We proactively plan for reliability and maximum demand events of our system.

Our electrical engineers plan system design around forecasted load requirements and reliability projects. From this study, they develop a construction plan in which our linemen then build. Proactive maintenance of the distribution system contributes to distribution system reliability. Load control and energy conservation by our members also play an important role during these extreme events. Thank you to all of our members who participate in energy management programs and also conserve energy when the need calls. REA members set a wonderful example of a community working together to make sure all have the necessary resources to see everyone through.

I often get asked, what do I lose sleep over in my role at REA? My answer is safety. I suspect every employee and board member at REA feels the same way too. We don't want to see anyone hurt around electricity: employees or members of the public. We lose sleep during events like this week. During dangerously cold temperatures we are very concerned about your safety and remain ever vigilant to keep the power and heat on. As with nature, there are factors not always within our control, but we can restore the power as safely as conditions allow and as quickly as possible. Thank you to those members who were affected by a temporary loss of power or heat for your patience. All of us at REA are very proud to serve our REA community.

Douglas County Car Care Program wins REA Touchstone Energy Community Award

It was an excellent first day on a new job for Kris Chisholm. Late in 2018, the new Executive Director (Kris Chisholm) of Douglas County Car Care, and the retiring Executive Director (Cliff Korkowski) accepted a special award from Runestone Electric Association. REA's Operation Round Up® Trust Board named Douglas County Car Care of Alexandria, as the winner of the REA 2018 Touchstone Energy Community Award, as well as a \$500 donation.

"Douglas County Car Care clearly demonstrates a strong commitment to community that we at Runestone Electric value highly," REA Community Trust Board President Dave Dziengel said. "We are very pleased to recognize Douglas County Car Care's contributions to our local communities."

The Douglas County Car Care Program receives donated cars, repairs them and gives them to needy individuals or families. "Lack of reliable transportation is the biggest barrier to employment for people in poverty. It is also a critical issue for seniors who want to continue to live in their own home," Korkowski said. "For many, getting a car means getting a job. Getting a car fixed means keeping a job or being able to continue living at home."

According to Korkowski, donated cars are brought to or delivered to Koep's Korner in Alexandria. There they are evaluated to determine if they are feasible to be repaired, and then donated to qualifying applicants. "If a family owns a vehicle, but can't afford the needed repairs, repairs are made using primarily volunteers. Repairs are completed by a *Car Care Saturday* repair shop (rotates between one of three community auto dealerships that donate space and labor for car repairs once a month), or a repair shop that is set up with reduced rates for Douglas County Car Care Program repairs," explained Korkowski.

"This area is blessed with many organizations that are doing wonderful things to better our communities," Kristin Dolan said. "We are pleased that as a Minnesota Touchstone Energy cooperative, we have this opportunity to recognize those who positively impact our communities!"

Space heaters can dramatically increase your electric bill


Use the formula below to determine what the monthly cost of operating a space heater will be before you plug it in.



Example for a 1,500 watt space heater:

(wattage divided by 1,000) x hours used x cost per kWh = cost per day
Example: (1,500 watts ÷1,000) x 24 hours x 11.18¢ (REA's rate Sept - May) = \$4.02 per day
To calculate a monthly cost multiply your cost per day by number of days in the month.
\$4.02 x 30 days = \$120.74. This is your cost per month.

Bottom line: space heaters are convenient, but expensive to use!
