# 2019 Annual Meeting highlights the cooperative community

Over 400 REA members attended the Runestone Electric Association 83rd Annual Meeting at the Alexandria Area High School on Monday, April 22. During the business meeting, Board President Barbara Johnson and CEO Kristin Dolan gave reports on the activities and financial condition of the cooperative. The Cooperative reported assets of over \$91 million with nearly 14,500 accounts at the end of 2018.

"In 1935 it was, for some of you, your grandparents, parents, your relatives that came together with their neighbors. They agreed that electricity was needed in their homes and on their farms," explained REA CEO Kristin Dolan. "All of them recognized no one else was going to do this, so it was up to them. They brought electric service to this community of members today. REA literally is this community, a community you and those before you, built. Today we provide safe, reliable, and affordable electricity to you in a responsible manner. No one can do it better than us because we know our community, we know us. You and REA are this community," Dolan said. Dolan also reviewed the upcoming member survey, Operation Round Up®, proposed bylaw changes, the May 1st rate changes, REA Energy Management programs, help provided to southern Minnesota cooperatives following the recent ice storm, and legislative challenges facing electric cooperatives.

REA Board President Barbara Johnson provided an overview of programs and activities at the Cooperative. She also provided insight into the director's role at an electric cooperative. "As your elected board of directors, we have oversight responsibility to you, our members. I can

assure you that each month we review the financial statements, the monthly and year-to-date operating report, the balance sheet, the operating ratios and all the disbursements for the month. We also hire an outside accounting firm to do a financial audit each year. We take our responsibility seriously to be accountable to all of you."


During this busy time of spring planting, always remember that overhead power lines and power poles may be nearby. Equipment continues to get bigger and bigger and could come in contact with power lines. To help keep everyone on the farm safe, make sure you have ample clearance when moving large machinery. Be extra careful when working near obstructions like trees and make sure that all farm workers know to keep an eve out for overhead power lines and other electrical

equipment that may be nearby. We have unfortunately had several poles hit with farm equipment this spring. Please take the extra time to be aware of the surroundings. We don't want to see anyone get hurt out there.

#### Electricity is a great value

Electricity is a valuable service. It enables an easier way of life for us all. It powers our everyday and for an average of just under \$4/day for the average residential home, it provides the conveniences afforded to us all. Whether you are enjoying supper with your family, working on your hobby or charging all of your electronics, we are there for you.

If you are interested in levelized billing from REA, we offer a Budget Pay Plan which averages your projected electric bills for the year and gives you a consistent monthly billing amount to pay each month. To qualify for budget pay, you must have been in residence at the same location



for one year and be current with your bill. Please contact REA for more information.

#### Legislative update

We are working hard to advocate for a responsible path forward on energy policy. It is a challenging environment for our electric industry legislatively. There are many concerning provisions proposed by the House of Representatives and the MN Governor.

Concerning provisions include a proposed mandate for electric utilities to provide aggregated customer energy usage data to the public upon request. REA's density is only 4.8 members per mile of line, and even less in portions of our territory, aggregated data isn't enough of a cushion to protect your privacy as the dissection of the data could determine an individual's member use.

There are proposed reporting requirements that mandate utilities file an annual diversity report on goals and efforts to increase diversity in our employment and the contractors we hire. At REA you do have diversity today, and we can always do more. It also starts at the education level in order to provide diversity at the applicant stage of the hiring process. Added reporting requirements associated with this adds to our administrative costs.

100% carbon free by 2050 and a requirement that generation comes from clean energy first is extremely concerning. Today the technology isn't available to achieve this goal without impacting reliability. We are very concerned with reliability, especially during extreme weather events, such as our recent polar vortex, and we are concerned with increased costs to achieve these goals.

We as an electric industry are asking for positive reform to the Conservation Improvement Program. As our industry becomes more carbon-free, let's work toward electrifying the economy. The current Conservation Improvement Program penalizes REA in achieving this. As you may recall in last month's Newsline, REA's generation portfolio is 48% carbon-free.

Thank you for participating in the democracy of your cooperative at our recent annual meeting. Thank you for voting for directors and also for the bylaw recommended change. It is important that you let your voice be heard in your cooperative. The Board of Directors, the employees and I greatly enjoyed meeting with you at the annual meeting, thank you for coming out and for your engagement in your cooperative.

### **REA Board of Director Meeting Highlights - March 2019**

- Mrs. Nelson reviewed the Financial Report for February 2019 and noted energy sales were very strong in February, with kWh sales 9% over budgeted. The approved general capital credit retirement, including the retirement from GRE, will be disbursed March 28.
- STAR Safety Compliance Specialist Lisa Tickhill presented the 2018 State of Safety Report and answered questions from the board.
- Appointed Dwayne Waldorf (District 1) and Mike and Erica Dickey (District 5) to the Member Advisory Council.
- CEO Dolan presented the Cooperative Finance Corporation (CFC) CEO's

Certificate and reported to the Board that the Cooperative met all of its mortgage requirements during fiscal year 2018.

- Mr. Rooney reviewed details of the new Nova Portal available this summer. The portal will provide timelines for interconnection consumers and the cooperative.
- CEO Dolan provided the 2017 2019 Strategic Plan for the board's review. Management will provide an update on the current plan in preparation for the strategic planning session scheduled for Friday, September 27, 2019.
  - The Regular May Board Meeting will be on May 28, 2019.

Guest speaker of the evening, Rick Lancaster, Great River Energy Vice President & Chief Generation Officer, reviewed Great River's strong financial year, cash back of patronage capital to member cooperatives, and the successful reduction of carbon dioxide at GRE power plants. Mr. Lancaster shared lessons learned during the polar vortex, GRE's power supply goal of 50% renewable energy by 2030, and innovations to electrify the economy. He also discussed concerning legislation involving the Conservation Improvement Program and efforts to be 100% carbon-free by 2050. President Johnson accepted a \$1,000 donation from Mr. Lancaster on behalf of Great River Energy for the Operation Round Up® program.

Immediately following the adjournment of the annual meeting, the board of directors held a reorganizational meeting to elect officers for the coming year. Elected to their positions were Barbara Johnson from District 2, President; Clif Patrick from District 6, Vice President; Gary (Andy) Anderson from District 1, Secretary; and Mike Loken from District 4, Treasurer. Other directors on the board include Audrey Hjelle, Steve Pederson, and David Staples.



## Rates to Change May 1st

At REA we work hard to control costs without adversely affecting reliability or service, but eventually the rising costs we pay for materials and services needed to deliver reliable electricity make it necessary to increase rates. The chart below reflects changes to the general service single phase rate and fixed charge effective May 1st. The rate change that goes into effect on May 1st will appear on the bill you receive in June for your May usage. Additional information is available at www.runestoneelectric.com.

General Single Phase	Current Rate	New Rate May 1
Fixed Charge	\$26.50 per month	\$29.25 per month
Energy (June - August)	\$0.1240 per kWh	\$0.1255 per kWh
Energy (Other Months)	\$0.1103 per kWh	\$0.1118 per kWh

### Call Gopher State at least 48 Hours before you dig!

If you are planning a digging project more than one foot in depth, it is **YOUR** responsibility to notify Gopher State One Call at least 48 hours before you dig. Gopher State will notify all parties that may have underground facilities in the area. Simply call, 1-800-252-1166 or requests can be made on-line at www.gopherstateonecall.org.

The Gopher State One Call Notification Center will take the responsibility of notifying all affected utilities within 48 hours of your call.

### Member-Owned Wires

The Gopher State One Call System will take care of all utility-owned underground facilities, but you are responsible for locating your own underground facilities. REA will locate all wires up to the metering point. All wires from there to your home and out buildings are your property, and other provisions must be made to locate these. Your electrical contractor or a line locating service is able to locate your lines for you.
