Is your Dual Fuel System ready for winter?

If you have a dual fuel heating system, also known as an off-peak system, now is the time to be sure your off-peak controls are functioning and your back-up system is prepared. Your fuel supply should be checked and chimneys cleaned.

Summer storms can damage equipment controls within off-peak heating systems. It is the member's responsibility to contact an electrical contractor should the system not be functioning correctly.

If you have electric heat, but are not sure if you are on the dual fuel program, please call REA at (800) 473-1722.

When will my dual fuel heating system be controlled?

- » Usually on the coldest winter evenings during periods of the highest demand for electricity. But other factors can lead to load control as well.
- » Between 100 and 120 hours per year (400 hours max.) and will not exceed 12 hours per control event.
- » Any time of the day, but typically in the early evening (4:30 9:30 p.m.) and occasionally in the morning.
- » Check on the likelihood of control by visiting www.RunestoneElectric.com and select "Today's Load Control".

Plans to escape the cold this winter?

Stop and read BEFORE turning off your water heater at your electric panel

Turning off your water heater when leaving on extended trips can be a good idea as long as you follow these friendly tips:

1. Check your breakers

Don't turn off the breaker if you have a yellow sticker (pictured) or if your electric panel lists your water heater circuit powering your off-peak meter and controller. If the breaker is turned off, you will miss out on the value of off-peak rates while you're away.

2. Disconnect Switch

Have your electrician install a disconnect switch. Installed next to the water heater, a disconnect switch lets you shut off your water heater while maintaining power to the off-peak meter and controller.

A Note from your *New* CEO **REA members experience fewer power outages due** to on-going underground cable replacement program

I would like to express my sincere thank you to the REA Board of Directors for entrusting me to lead this great organization. Also, a big thank you to the REA employee group for all of their support and well wishes extended to me upon this decision. I am looking a to REA's future success and

forward to contributing to REA's future success and building upon a great legacy with you!

Now that the summer storm season has come to a close and we begin our annual budget process, the Operations team looks back on the year's outage statistics and makes a work plan for the upcoming year. Since 2009, one of the key statistics we monitor closely are outages due to failing underground cable. Prior to 1986, much of the underground cable manufactured in the United States had major deficiencies that didn't become evident until after it was installed and in-service for several years. The manufacturer defects included poor design, insufficient control over the extrusion process, and overall quality control problems. The early underground cable often failed prematurely, which caused the manufacturers to regroup and improve the product. REA has been using the improved underground cable design in various forms since 1986. Underground cable purchased after the late 1980s has performed well, with a great track record.


However, we still have pre-1986 underground cable in use within the REA service territory which continues to fail. Since 2009, REA has had a specific budget initiative to target underground cable replacement of line sections that experience outages. On average, we spend nearly \$600,000 each year to replace failing underground cable. Each underground outage is tracked and entered into a spreadsheet that includes the length of the line segment, how many accounts were involved in the outage, the number of outages, and the estimated cost to replace the underground cable. The projects are prioritized based upon various criteria. The cost estimates are then totaled and added to the next year's capital construction budget.

After budget approval in December, the Operations team begins the process of permitting, environmental review,

preliminary design, and placing material orders. Finally, when spring arrives, the projects are staked in the field, Gopher State One Call (line locating) notifications made, and our crews begin the construction process.

The focus on underground cable replacement has significantly improved power reliability. When we began this project twelve years ago, underground cable failure was the leading cause of outage time for REA members, with a total of 2,669 accounts without power for 7,303 hours. In 2019, the hours off dropped to just 530 accounts without power for 1,191 hours. As you can see from the graphic, REA's investment in replacing failing underground cable has substantially reduced outages.

In addition to replacing failed underground cable, we have also adopted the process of replacing overhead powerlines with underground cable whenever possible. I will touch on this and other initiatives to improve power reliability in the months to come. Doing all we can to safely keep your lights on is our number one priority at Runestone Electric.



REA Board of Director Meeting Highlights - September 2020

- » Mrs. Nelson reviewed the Financial Report for August 2020 noting REA has continued to have sales higher than budgeted for the year. Operating expense is under budget for the year due to mild weather and fewer outages allowing more labor time to be spent in the field working on capital projects, and less expense for events and training due to the Covid-19 restrictions. In August, we paid off FFB principal with our Cushion of Credit (CoC) balance, as allowed by the revision to the CoC Program in the 2018 Farm Bill. Payroll tax credits are being claimed for 2020 employee leave allowed in the Families First Coronavirus Response Act.
- » Interim CEO Haman presented the 2020-2034 Long-Range Plan. No board action was required. He also provided an update on Covid-19 effects of on the REA workforce and explained how the Families First Coronavirus Response Act (FFCRA) works.
- » Mr. Rooney reviewed the 'SotaGrown ribbon-cutting at West Central Area Schools, ReChargeMN recognition, REA's generator program and the cancellation of the community education EV class.
- » The regular November Board Meeting will be November 24, 2020 at 9:00 a.m.

How many years have you been on the board?

I have been on the board for 1.5 years. I represent the townships of Brandon, Holmes City, Moe, Lake Mary, and Solem.

Where do you live?

We live 15 miles west of Alexandria, straight north of Andes Tower Hills.

Where is your hometown/high school?

I grew up in rural Kensington and graduated from Hoffman-Kensington High School in 1989.

Tell us about your family.

I met my wife, Amy, back in 1995 at the Barrett Street Dance. Two years later, we were married. And since then, we've had four kids. We have Dawson (21), is studying construction management at MSU in Moorhead. Gage (18) is studying ag systems at NDSU. At West Central Area Schools in Barrett, we have Ryder (16), a junior, and Addison (13), an eighth-grader.

What is your passion as a board member?
