## A Note from your CEO Rate changes appear on your bill this month

The bill you receive this month reflects a \$51 monthly fixed charge for general service accounts and a \$.0969 per kWh energy charge. Other rate classes will experience changes as well.

We have spent the past year talking about the fixed charge and explaining the gap between the basic cost of service (\$51 per account per month) and the former monthly fixed charge (\$29.25 prior to October 1st). With the new fixed charge of \$51, the cost of service is now accurately reflected.

I have said it in the past, and I continue to believe this historic decision to change the fixed charge will serve our members well in the future.

#### **Financial assistance**

Inflation and the increasing cost of just about everything is stressful for everyone. Members with past-due accounts should contact our office to set up payment arrangements. It is also essential to seek out the energy assistance provider that serves the county where you live. You can find a list of energy assistance providers by visiting the *financial assistance* page on our website (www.runestoneelectric.com) or simply call our office at 800-473-1722. It is extremely important to seek help before you fall behind.

#### More load control anticipated this winter

As I mentioned last month, our wholesale power supplier, Great River Energy, anticipates load control to increase to about 200 hours this year compared to about 100 hours of control in the past. We also expect more control events in the morning.

With the transition from fossil fuel power supply sources to more renewables, the wholesale cost of electricity has become indexed to natural gas. Forecasts predict the price of natural gas this winter will be nearly triple what was paid as recently as 2021.

REA's Energy Management programs can help minimize the impacts of the volatile energy market on our energy rates. In recent years we have used these programs, specifically the Dual Fuel program, to interrupt electric heating sources at times when the price of electricity is high.

We are thankful for members who participate in the Dual Fuel program, and we want them to be aware of these changes to ensure they have adequate backup fuel (propane, wood, fuel oil, etc.) for the anticipated increase in control hours. The rush is on! Area farmers are busy finishing harvest chores, and REA's crews are busy with fall construction projects before the ground freezes. The long shadows of the digger derrick truck are a tell-tale sign of the season ahead. Crews recently installed a new underground service southeast of Garfield to service a Great River Energy switch. REA reminds everyone to use caution when working near power poles and other electrical equipment. Always look up to check clearances.

## **REA Board of Director Meeting Highlights - September 2022**

- » Reviewed the Financial Report for August 2022. The August margin was a negative variance from budget due to higher kW demand/power cost in the month. The year-to-date margin has a negative variance from the budget, in large part due to the May storms. Other expense variations are in OCR and substation maintenance, the water heater program, and office building maintenance.
- » Approved an estate capital credit refund, as allowed by REA Policy C12 – Capital Credits.
- » STAR Energy Services Electrical Engineer McKade Kleinknecht, PE, presented the 2023-2026 Construction Work Plan. With an estimated cost of \$22,098,628, the Work Plan represents distribution system improvement projects, aging infrastructure, line conversion from overhead to underground, and load management receivers. The board approved the Work Plan.
- » The regular November Board Meeting will be Tuesday, November 29, 2022 at 9:00 a.m.

## Dual Fuel Participants Tips & Reminders:

During the heating season, the electric heat portion of your dual fuel system may be controlled up to a maximum of 400 hours, however this is rare.

- » Control will not exceed 12 hours per control event.
- » If you're on dual fuel, check the electric and non-electric (dual) parts of your heating equipment now.
- » Fill your fuel tank full in case it needs to run for hours at a time.
- » We anticipate more control in the morning.
- » Check on the likelihood of control by visiting www. RunestoneElectric.com and select "Today's Load Control"
- » Sign up to get text messages on control days - text #loadcontrol to 22300.

## **Correcting Neutral-To-Earth Voltage Conditions**

As a member of Runestone Electric Association, you should feel free to call us anytime with concerns related to your electric service. One area that can be a concern, particularly for livestock farms, is stray voltage.

Electrical supply systems delivering power to farms, homes and businesses are grounded to the earth to make them as safe as possible and to ensure their reliability. Proper grounding of these electric systems is not only essential, but a requirement of the codes that govern both home and utility practices. Because electric current is designed to be carried by the grounded conductors (neutral conductors), these wires will have a small voltage associated with them. Objects that are bonded to the neutral conductors will therefore have a voltage on them.

A consequence of the electrical system in the United States is "Stray Voltage". Stray voltage is often defined as a small voltage (less than 10 volts) that exists on grounded objects that are within close proximity to livestock. If an animal touches a grounded object, such as a metal drinking cup, while standing on an ungrounded floor or on soil a current can flow through the animal's body. If the voltage level is high enough, the resulting current may be sensed by the cow. Stray voltage can become a cow's behavioral issue with the livestock operator. Hesitation to drink from a waterer, or enter a parlor can be a behavioral symptom of stray voltage.

Although stray voltage is present on all distribution systems, humans usually do not notice it. However, livestock - especially dairy cows - are particularly sensitive. The goal is to keep the voltage level low enough that it will not cause a problem on the farm. Stray voltage can also result from deteriorating and improper wiring, faulty equipment, or improper grounding. Because of high electric use, high humidity, silage acids, and manure, a dairy farm is not the ideal environment for electrical wiring.

REA offers stray voltage investigations at no charge.
