REA Members Gather for the Annual Meeting

Runestone Electric Association held its Annual Meeting on Thursday, April 27, at the Alexandria Area High School Performing Arts Center. Board of Directors seats were determined in Districts 3, 6 and 7, and scholarships were awarded to 18 students (see story on page 3).

Runestone Electric's bylaws allow for uncontested director elections to be elected by acclamation, as in District 3, where Audrey Hjelle, ran unopposed and was reelected. In District 7, Matthew Mattson, ran unopposed and was reelected.

In the District 6 Director election, Joel Seela was elected to the Board with 128 votes. Bruce Harvey received 90 votes and Paul Stennes received 65 votes. Hjelle, Mattson and Seela will serve three-year terms.

During the business meeting, Board President Barbara Johnson and CEO Al Haman gave reports on the activities and financial condition of the Cooperative. "At the end of 2022, the total assets of the cooperative were \$102 million. That includes plant assets like the office and warehouse, substations, lines, poles and transformers. We finished 2022 with 211 new accounts and surpassed 15,000 total accounts," said President Johnson.

In his presentation, CEO Al Haman said some of the biggest challenges of 2022 were three major summer storms, with storm expenses exceeding \$800,000. Looking at 2023, Haman said the Cooperative is challenged by inflation and supply chain issues while working to maintain and improve reliability. Focusing on the future, Haman highlighted the Carbon-Free by 2040 bill and two large transmission line projects within REA's service territory.

Retiring REA director, Clif Patrick, was recognized for his nine years of service representing District 6.

"Thank you to our members who made time to attend the Annual Meeting. I appreciate your feedback and kind words," Haman said.



A Note from your CEO Highlights from the Annual Meeting

Thanks to everyone who attended our Annual Meeting. We are happy to see so many members willing to attend a meeting on a busy spring night. I thought I'd recap a few items I shared during my report to the membership.

- First and foremost, the three summer storms of 2022 were a huge challenge for us. Our storm expenses exceeded \$800,000, including normal storm restoration activities like labor and fuel and the cost of poles, wires, and damaged transformers. As a cooperative, REA can apply for assistance from the Federal Emergency Management Agency, commonly known as FEMA. I'm happy to announce that we have been approved for \$800,000 in aid and hope to receive that soon.
- Supply chain and inventory have become very difficult to forecast, and cost increases are beyond our control. In some cases, delivery dates keep pushing out. At the same time, material with long lead times suddenly shows up very early. Bucket trucks are a perfect example. We have a system of determining when trucks should be replaced with a good chance of receiving a new one before expensive repairs are necessary. We may have waited a year for delivery in the past, but now we have no guarantee of when replacement trucks will be delivered.
- Total accounts, or meters, passed 15,000 for the first time in the cooperative's history. We continue to see steady growth; however, sales are not increasing. The best explanation we can come up with is energy efficiency. New homes are equipped with modern appliances and weatherization, and older homes are getting new, energy-efficient appliances and other upgrades.
- REA is pleased to provide member outreach and public education on a variety of subjects, including

energy conservation, electrical safety, contractor training programs, electric vehicles, and more. You may have heard that grants and rebates are available in the federal Inflation Reduction Act. These new programs, along with activities at the state level, are driving many changes in how electricity will be used in the future. We intend to remain knowledgeable in these areas and can be a trusted source of information. Please let us know if you have questions. We can give you honest answers.

- Earlier this year, the Minnesota Legislature passed, and the Governor signed the Carbon-Free by 2040 bill. The bill increases the renewable energy standard for generating sources in place since 2007 and creates a new carbon-free standard for retail sales: the electricity we deliver to you. Great River Energy (GRE), REA's wholesale power supplier, is responsible for compliance with the new law, and we will advocate at GRE for the best approach for our membership.
- Finally, I want to make you aware of two large transmission projects coming through our system. Many of you have or will receive notice of public meetings to introduce the projects. The Alexandria-Big Oaks project involves adding a second set of wires to the line that runs along the interstate. That project should have minimal impact in this area since the towers are already in place. The second is a new line from the Ortonville area to Alexandria. The possible corridor runs east of Ortonville to Benson, then north to Alexandria. The line will terminate in the large transmission substation south of Alexandria along I-94. We will share information as these projects move through the planning process.

Good luck to our agribusiness members, as planting season should begin soon. Please remember to be safe, especially around power lines and electrical equipment.

REA Board of Director Meeting Highlights - February & March 2023

February

» Reviewed the Financial Report for January 2023 noting sales were down for January 2023, resulting in a decreased gross margin. The negative effect on the REA margin was offset by expenses lagging the budget, particularly distribution plant maintenance items.

- » Selected Director Hjelle to serve on the Great River Energy Board of Directors and Director Anderson to serve on the STAR Energy Services Board of Governors.
- Accepted pole inspection, substation vegetation control and padmount transformer inspection contracts as part of the 2023 Operations and Maintenance Budget.

March

- » Reviewed the Financial Report for February 2023 noting sales lagged behind budget in February. The margin for the year is under budget due to lower sales and to operations expenses incurred earlier than projected. The unpredictability of both cost and delivery timing for materials is still difficult.
- » Accepted the 2022 Audit Report. A clean opinion was issued.
- » STAR Energy Service Compliance Specialist Lisa Tickhill presented the 2022 Safety Year in Review.
- » Approved Electric Vehicle (EV) Charging Three Phase Service (EVP3) rate to coincide with the GRE Customer Specific Rate.
- » The regular May Board Meeting will be Tuesday, May 30, 2023 at 9:00 a.m.



What are Those Markers?

With construction season upon us, you may see flags or other markers within the road right of ways or perhaps even in your yard. Here's why:

When notified by Gopher State One Call, REA will mark our underground wire with red flags and red spray paint. Other utilities will mark their equipment with different colors (see chart below). It is required by law to call Gopher State One Call before you dig. If you see red markers, it doesn't always mean REA is conducting the work, it could be anyone who requested the locate, such as another utility, an excavator, or even you.

If the markers are white and not red, they are representing proposed excavation. White markers can be used by anyone preparing for an excavation project. REA uses stakes with white ribbon, like pictured to the right. If you see these, they typically represent where we will be plowing in new underground or replacing old underground.







Quick Note about locating:

Remember that utility power lines will be marked for free, up to your main meter. Underground powerlines from your main meter inward, however, are the responsibility of the member. Property owners need to call an electrician or a powerline locating company to have their private lines marked. A list of private powerline locators can be found at gopherstateonecall.org.
