# **6 WAYS TO SAVE ON YOUR SUMMER ELECTRICITY BILL**

The summer heat can sometimes feel impossible to beat. Your air conditioner (A/C) is working overtime to try and keep your home or business cool and comfortable. The harder your A/C is working, the higher your electricity bill could be. Help out your home and your wallet by trying these six, simple ways to save on your summer electricity bill.



Regularly inspecting your A/C unit can ensure it is functioning as efficiently as possible. Vacuum air vents regularly to remove dirt, dust and pet hair build-up. Replacing a dirty A/C filter every month or two can lower your energy usage. If you suspect your A/C unit is in need of service, be sure to reach out to a certified HVAC technician.



Don't let the savings a fan could offer breeze past you! A ceiling fan works great when paired with your A/C unit. The wind chill effect created by a fan allows you to keep your thermostat four degrees higher without a change in comfort.



You heard us right! A conventional oven can heat a house or apartment and force your A/C to keep up. This summer, bust out the crockpot and fire up the grill to enjoy some delicious summertime meals while also saving on your electricity bill!

The best thing you can do to avoid sunbathing in your living room is to keep the blinds closed on southern and western-facing windows. Open northern-facing windows to allow natural light into your home without heating it up.



An LED light gives off significantly less heat and uses 75% less energy than incandescent bulbs. Soak up those cool savings by switching your home or business over to LED bulbs.



If you aren't using it, unplug it. Computers, toasters, gaming devices and other gadgets all generate a small amount of heat in a room. Unplug to save on your electricity bill all year-round.



### A Note from your CEO Construction season at REA

Summer is construction season at REA! The 2023 Work Plan includes many projects, such as building new service connections, service upgrades, moving powerlines for road construction projects, pole

replacements, and the list goes on.

Some of our ongoing construction projects include replacing yard poles with overhead meter loops, changing out porcelain fuseholders, replacing aged transformers, and adding electronic "smart" circuit breakers to several substations.

Other construction projects are necessary due to road construction projects resulting in the need for our lines and poles to be moved. This summer, REA crews will assist Integrity Contracting out of Shevlin to install over eleven miles of underground cables along Co Rd 15 and near Minnewaska Area High School in Pope County, Co Rd 8 in Douglas County, and near the Gorton Substation in Grant County.

Even though we have adopted the process of rebuilding overhead powerlines with underground cable whenever possible, the fact remains that we have nearly 37,000 power poles across our system. STAR Energy Services, a subsidiary of REA, documents and periodically inspects every pole. Our Work Plan includes the replacement of approximately 380 poles per year that fail the inspection process.

### **Inspecting Power Poles**

STAR Energy Services will conduct pole inspections in Framnas, New Prairie, Hodges and Walden Townships this summer. You will be able to identify the vehicles by the STAR Energy Services logo, and REA's name will also be visible on the vehicles.

The inspection begins with a visual inspection of the pole, checking insulators, hardware, conductors, trees touching the wire, etc. Next, a sound inspection is done by hammering on all sides of the pole. The hammering produces a sound that can indicate if decay is present in the pole. If decay is present, the pole is tagged for replacement. A boring inspection comes next by drilling a hole into the pole at a 45-degree angle below the groundline - wood shavings and any voids that the drill hits will indicate if any decay is present. Then a treated plug is inserted into the drilled hole.

A tag indicating the year of the inspection is placed on the pole. Technicians then confirm the pole manufacturer, height and class of pole, year and species of pole. All of this information is stored electronically for future reference.

Pole inspection and replacement is one of our many initiatives to improve power reliability. Our top priority at Runestone Electric is doing all we can to keep your lights on safely.

# Small Change Can Make Big Changes with **Operation Round Up**<sup>®</sup>



Through the contributions of Runestone Electric Association's participating members, the Operation Round Up® Trust Board recently approved **\$11,590** to assist local community programs during its quarterly meeting.

**REA's Operation Round Up Trust** Board, a voluntary board of seven REA members, reviewed and considered 23 grant applications and distributed funds to 21 projects and programs this past guarter. Community-based projects and programs have received over \$1.2 million since the program's inception in 2003. On average, participating REA members contribute \$6.05 for the year. Proof that small change adds up. Best of all, 95% of all funds collected are distributed as grants.
